Invitation for Bids for procurement of Fabricated Steel Parts for Trail Bridges

1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Machhapuchhre Rural Municipality, Lahachowk, Kaski for **Trail Bridge Program** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Bid is open to all eligible Nepalese Bidders.
2. The Machhapuchhre Rural Municipality, Lahachowk, Kaski invites sealed bids or electronic bids from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Bid Documents.
3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may not apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.

A complete set of Bidding Documents may be purchased from Machhapuchhre Rural Municipality, Office of Rural Municipal Executive, Lahachowk Kaski by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **amount 3000 .00 till April-18, 2019 within office hour**.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Sealed or electronic bids must be submitted to the office Machhapuchhre Rural Municipality, Office of Rural Municipal Executive, Lahachowk, Kaski by hand/courier or through PPMO website www.bolpatra.gov.np/egp. on or before **12:00 Noon on April-19, 2019** Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours on April-19, 2019** at the office of Machhapuchhre Rural Municipality, Office of Rural Municipal, Lahachowk, Kaski.
9. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting mentioned below, which shall be valid for 30 days beyond the validity period of the bid. (i.e. 120 days)
10. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
11. Pre-Bid Meeting shall be held at the office of Machhapuchhre Rural Municipality, Lahachowk, Kaski at **13:00 hours on Apri-09, 2019**
